By enrolling your pet (PET) at Muttessori School for Dogs (MUTTESSORI), for a fee to be arranged at the time of each visit, and after having reviewed and read this Agreement, the PET PARENT (PARENT), and MUTTESSORI hereby agree to the following terms and conditions.

Terms and Conditions

- 1.) MUTTESSORI agrees to exercise reasonable care of the PET placed in its control, including the provision of individual sanitary quarters, proper and regular feeding and such special care as specifically requested by the PARENT and agreed to by MUTTESSORI.
- 2.) In the event the PET becomes ill while in its care, MUTTESSORI will contact the PARENT'S veterinarian of record, or if the situation demands urgent attention in the opinion of MUTTESSORI, the PARENT hereby authorizes MUTTESSORI to contact a veterinarian of its choosing and MUTTESSORI is specifically authorized to obtain such prompt attention as the PET requires. All costs incurred by MUTTESSORI, if any, shall be the obligation of the PARENT and shall be promptly paid to MUTTESSORI as reimbursement upon notification, which may be at the time of the pick-up of the PET. The PARENT shall hold MUTTESSORI, its officers agents, and employees from any and all action, or actions, injuries or damages, caused to such PET as the result of such veterinarian's treatment, or authorized conduct of MUTTESSORI concerning such treatment.
- 3.) MUTTESSORI shall not be responsible, nor held liable, for any injury, illness, and/or death to PET placed in its care from disease or natural disaster, including but not limited to, tornadoes, storms, civil riots, or any other acts beyond MUTTESSORI'S control. However, if a PET'S demise or loss occurs while in the care of MUTTESSORI from any other cause, except "old age" MUTTESSORI will either (a) replace the PET with a similar PET; or (b) provide a cash payment to PARENT in an amount equal to the value of such PET at the time of such loss or (c) Three Hundred and 00/100 (\$300.00), whichever is less. In no event will MUTTESSORI be liable for any direct or indirect consequential or inconsequential damages to the PARENT of the PET resulting from either the PET's illness and/or the PET's death.
- 4.) PARENT understands the PET will be leash-walked three times daily during its stay. If the PET escapes due to an aggressive act or nature, MUTTESSORI shall not be responsible nor liable for the loss of the PET.
- 5.) PARENT represents that he/she has legal ownership and title of their PET and accepts total responsibility for all actions taken by MUTTESSORI, and all charges which may arise out of this Agreement.
- 6.) PARENT represents that PET has received all proper medical treatment including all preventative shots, including but not limited to; rabies, parvo, distemper, corona, bordatella, and a negative fecal test.
- 7.) PARENT shall be responsible for any costs, damage, or injury caused to MUTTESSORI, its officers, agents, employees, guests, or equipment (i.e. bowls, bedding, cages), resulting from, or caused by, PET PARENT'S PET.
- 8.) PARENT shall retrieve their PET on the designated date and time unless MUTTESSORI receives notification from PARENT concerning delay. A PET shall be considered abandoned if not retrieved within seven (7) days of designated date. MUTTESSORI will then humanely dispose of or euthanize the PET. This in no way releases the PARENT of financial obligation for the cost of the PET'S boarding and/or disposal fees.
- 9.) PARENT shall reimburse MUTTESSORI for all costs and/or legal fees incurred by MUTTESSORI resulting from breach of this Agreement.
- 10.) PARENT agrees, by signing this Agreement, at the time of the initial visit, that PARENT shall be bound by the terms of this Agreement, now and at any time in the future when PARENT utilizes the MUTTESSORI facility.
